Policy #2 - Event Scheduling Priority:

All Events held at Rio Salado Sportsman's Club will be subject to an order of priority when scheduling the use of Ranges and other facilities.

Procedures - Event Scheduling Priority:

Events will be scheduled according to the following:

<u>Priority ONE</u> – Sanctioned Competitive Events, in priority order.

- 1. International
- 2. National
- 3. Regional
- 4. Sectional
- 5. State
- 6. RSSC Division regularly scheduled matches.

<u>Priority TWO</u> – Non-Sanctioned Competitive Events, in priority order

- 7. National
- 8. Regional
- 9. State
- 10. RSSC Divisions
- 11. All Other User Groups

Priority THREE – Non-Competitive Events

EXPLANATION:

A. For Priority One – Sanctioned events are those authorized by a recognized shooting organization such as the NRA, IPSC, NMIRA, NSCA, ASRPA, etc. Documentation must be provided by the Sanctioning parent organization for the event. The fact an event has shooters from elsewhere does not make the event an international, national, or state level event – the event must be recognized by the sanctioning organization as being of that level and it must be sponsored by RSSC; therefore, all income received must be accounted for through respective "Division" account.

- B. Competitive Events are any shooting events offering awards, prizes or points as a result of competition.
- C. RSSC Divisions are those groups which have a Division Director seated on the RSSC Board of Directors, and recognized by the RSSC By-Laws.
- D. Conflicts in Non-Club member User Groups will be resolved according to the following priority: Hunter Education, Commercial, Police, Military, Security, Conservation Groups, Schools, Other Clubs, General.
